Tournament Conditions

1. The Tournament Committee shall have entire control of the tournament. The Committee may refuse the entry of a player without providing a reason and reserves the right to reduce, re-schedule any matches as required, in the case of extenuating circumstances.
2. This tournament will be conducted in accordance with the Uniform Tennis Australia's Anti-Corruption Program. Tennis Australia's Member Protection By-Law, the applicable tournament rules and regulations and the Tennis Australia's Code of behaviour (each as amended from time to time). "I acknowledge and agree that all Tennis Australia policies can be readily viewed at www.tennis.com.au and that it is my responsibility to view these and seek clarification, if required from the Tennis Australia Tournaments & Competitions Department". In addition this website has details of the Tennis Australia Disciplinary Statement, Publicity and Promotion and Filming/Photography at Tennis Australia Sanction Tournament policies.
3. **Spectator Behaviour Statement:** Inappropriate spectator behaviour could result in denial of entry at future Tennis Australia or Member Association sanctioned events, and will be dealt with in accordance with these policies. This includes, but is not limited to, tennis venues, hotels and transport vehicles.
4. **Publicity and Promotion:** I consent to him/her being involved in any publicity connected with a Tennis Australia Sanctioned Tournament, including media interviews, photographs and TV footage. Please inform the tournament organiser if you don't wish him/her to be involved in publicity".
5. **Membership Number:** It is mandatory that every entrant be a member of an affiliated tennis club within their state of reside. This shall not apply to events which carry ATP/WTA/ITF world rankings.
6. **Tennis Coach Statement:** As an entrant in this event, TA recommends that your coach is a TA certified coach. This will ensure the following:
 - (a) The coach has currently updated his/her coaching credentials
 - (b) Has been police checked
 - (c) Has an updated first aid qualification.Further information on coaches, including a list of certified coaches, can be viewed at www.tennis.com.au/certification
7. I acknowledge that all Tennis Australia policies can be readily viewed at www.tennis.com.au and that it is my responsibility to view and seek clarification, if required from the Tennis Australia Tournaments & Competition Department.
8. **Registration with Tennis NSW:** All entrants are to be registered members of Tennis NSW for the current year to June 2011. Players must quote their registration number on the entry form. Unregistered players must pay the registration fee of \$14 for Juniors and \$21 for Adults in addition to their entry fee. This condition does not apply to Interstate players provided they show proof they are registered with their State body.
9. **Withdrawals:** Withdrawal deadline is 5pm, 14 days prior to the commencement of the event. Athletes who withdraw after the withdrawal deadline will be penalised under the Tennis Australia Code of Behaviour except (1) in those cases where a medical certificate is produced prior to the conclusion of the tournament. (2) Where another reasonable case is provided to the Referee for non-participation.
10. **Entry Fee Refunds:**
 1. Any withdrawals before the 14 day withdrawal deadline will be issued a full refund, less an administration fee of \$5.
 2. Any medically supported withdrawal after the 14 day deadline, but before the release of the draw, will be issued a refund of 75% of the entry fee.
 3. Any medically supported withdrawals after the release of the draw will be issued a refund of 50% of their entry fee.
 4. Any non-medically supported withdrawals after the 14 day deadline, but before release of the draw will be issued refund of 50% of their entry fee.
 5. Any non-medically supported withdrawals after release of the draw will not be issued a refund of their entry fee. The Associations address is PO Box 152, Northmead NSW 2152.
11. **Number of events:** Players may enter a maximum of 3 events.
12. **Age eligibility:** The age eligibility for junior events will be the player's age at the 31st October 2010.
14. **Tournament Draw:** *The draw for all events will be posted on the website – tournaments.tennis.com.au – three days prior to the first day of the main draw.*
15. **Reporting for matches:** Players must report to the Tournament Office fifteen (15) minutes prior to their scheduled match, regardless of weather conditions.
16. **Match Format:** Main Draw Singles: Best of Three Tie-break sets, Consolation Singles: Two Tiebreak sets; with a 10 point Match Tie Break at 1-set all, Main Draw Doubles: Two Tiebreak sets; with a 10 point Match Tiebreak at 1-set all.
17. **Tennis attire:** Competitors must wear recognised tennis attire.
